\_\_\_\_\_ shall have reasonable and liberal visitation pursuant to the following schedule:

(A) Weekends: The \_\_\_\_\_ shall have custody of his\her children every other weekend of each and every month from Friday evening at 6:00 o'clock p.m. through Sunday evening at 6:00 o'clock p.m.

(B) Holidays: The \_\_\_\_\_ shall have custody of his\her children on alternating years as follows:

<u>Holiday</u>	<u>Odd year</u>	<u>Even year</u>
New Year's Day	father	mother
Easter	mother	father
Memorial Day	father	mother
July 4th	mother	father
Labor Day	father	mother
Thanksgiving	mother	father
Christmas	father	mother

Custody shall commence at 7:00 o'clock a.m. and end at 7:00 o'clock p.m. with the exception of Christmas Holidays.

On the odd year, the \_\_\_\_\_ shall have custody at 1:00 p.m., December 24th to 3:00 p.m. on December 25th, and he/she shall have custody on December 28 at 1:00 p.m. to 1:00 p.m. on January 1.

On the even year, the father shall have custody at 3:00 p.m. on December 25th to December 30th at 3:00 p.m.

(C) Special Days:

(1) Fathers Day: He has custody of his children on each Fathers Day, regardless of whose weekend it may fall on commencing at 7:00 a.m. and ending at 7:00 p.m.

(2) Mothers Day: She has custody of her children on each Mothers Day regardless of whose weekend it may fall on commencing at 7:00 a.m. and ending at 7:00 p.m.

(3) Parents' and Children's Birthdays: Each parent shall have custody of their children for at least three (3) hours on each of their respective birthdays, regardless of the

weekend visitations set out above.

(D) Summer: The \_\_\_\_\_ shall have custody with his\her children for four weeks during the summer months of June, July and August, taking into consideration the summer vacations of the parents. The four weeks shall be in two week intervals, not consecutive, in order for the \_\_\_\_\_ to have one weekend (Friday at 6:00 p.m. to Sunday at 6:00 p.m.) in between the \_\_\_\_\_'s summertime custody. The parents shall communicate with one another to work out the summer custody at least two weeks prior to that occasion.

(E) Other: The \_\_\_\_\_ shall have such other periods of custody as may be mutually agreed upon between the parties.
